Due to Ohio's passage of Senate Bill 150, any producer or applicator who applies commercial fertilizer to 50 or more acres must be certified by no later than September 30, 2017. This new legislation provides the state with tools to continue to serve a growing population while protecting Ohio's natural resources. Focusing on science-based practices, the new law requires farmers with 50 or more acres who apply commercial fertilizer, or applicators who apply commercial fertilizer to 50 or more acres to attend a course on fertilizer application. This certification process supports responsible agricultural practices and promotes the 4R program (Right source, Right rate, Right time, and Right place) while allowing Ohio to continue to grow its vital agriculture industry.

Growers or applicators who are current with their Private and or Commercial Pesticide Applicator license need two hours of Fertilizer Certification training. This training can be accomplished by attending either a Private Pesticide Applicator recertification session that has a Fertilizer Certification component with it (no commercial pesticide recertification credits offered), an Agronomy Day program, or attend a stand-alone Fertilizer Certification session. The Fertilizer Certification is in addition to your Private and or Commercial Pesticide Applicator recertification requirements.

Growers or applicators who do not have a Private and or Commercial Pesticide Applicator license need three hours of Fertilizer Certification training. This training can be accomplished by either attending an Agronomy Day program or attending a stand-alone Fertilizer Certification session. Only the Agronomy Day and Stand-Alone Fertilizer Certification sessions have the three hour components.
